Compendium of verification rules for report

1 Introduction

This compendium groups all the verification rules that apply to report BOP 1.1 «Breakdown of certain elements from the income statement of credit institutions».

The instructions relating to data collection are described in the documents Instructions and Report relating to report BOP 1.1 «Breakdown of certain elements from the income statement of credit institutions».

The objective of the present document is to describe the various internal consistency checks for the statistical report BOP 1.1 «Breakdown of certain elements from the income statement of credit institutions».

We should like to stress the importance of the quality of the data transmitted to the BCL and the necessity to submit the data to the verification rules detailed in the technical documentation. Only a rigorous control undertaken during data production will allow to respect the quality requirements as well as the reporting delays. This point is all the more important since the data collected will be checked by the ECB before aggregating it with the data of the other Member states. Any error or important negligence will have harmful repercussions on the reputation of the whole community of the Luxembourg financial institutions.

2 Verification rules

The verification rules are split into 2 groups, namely those that have a permanent character and those that have a temporary character. As far as concerns the verification rules having a permanent character, we invite the software providers to implement these rules whereas the temporary verification rules are more specifically addressed to the reporting agents. The latter are invited to take into account these rules when preparing the data.

At this stage, report BOP 1.1 only contains permanent verification rules.

2.1 Permanent verification rules

2.1.1 Internal verification rules for report BOP 1.1

2.1.1.1 Counterparttype

The type of counterparty (counterpartcode) must take the value «23».

2.1.1.2 Counterpartcode and counterparttype

- The type of counterparty (counterpartcode) consists of 3 numeric positions.
- The code of the counterpart (counterpartcode) must be identical to the code of the declarant (declarantcode).
