2. Connectivity general aspects by the BCL



Connectivity testing principles

- The Connectivity testing is **a mandatory test phase** of the User Testing.
- Its purpose is to demonstrate the participants' ability to reach the new ESMIG (Eurosystem Single Market infrastructure Gateway) that allows them to connect to the Target Services.
- Prior to starting the connectivity test, the participant will ask its NSP to be included in the Target CUG (closed group of users); the NSP will pass that request to the BCL which will process it.
- Participants are asked to send evidence of their successful connection to the BCL (A2A participants shall send two pieces of evidence, one for U2A and one for A2A)
- The Connectivity Test cycle started on 1st Sep 2021 (notification by BCL on 31 Aug) and will remain open until 31 Nov 2021
- These dates are reflected in the Eurosystem Target Consolidation key milestones plan



Overview of TARGET services connectivity to ESMIG

- Following the re-scheduling of the T2-T2S Consolidation project, TIPS and T2S will move to ESMIG before the T2 service
- TIPS will use a full ESMIG connection as of November 2021
- T2S will be accessed via ESMIG as of June 2022 as the current License Agreement governing the connectivity to T2S will expire in June 2022
- ECMS is the last service connecting to ESMIG as of its planned go-live date in November 2023



A2A connectivity

Initially, the BCL expected to receive a copy of the admi.007 rejection notice to evidence your A2A connection.

However, several configurations were detected where admi.007 messages were not released although the participant's A2A configuration was enabled.

Therefore, the valid evidence evolve:

- For Store and Forward traffic (used for settlement messages) it is possible to subscribe for the Delivery Notification to get the confirmation from your NSP that your message was delivered to T2.
- For Real Time traffic (used for queries), an admi.007 'time out' is sent after 40 seconds to inform about the triggering of the timeout management process (which is an expected behavior as no backend module is present).

The real-time transfer, which requires that both parties, i.e. the sender and the receiver, are available at the same time to ex change the relevant data. In case of unavailability of the receiver, no retry mechanism is foreseen.

The store-and-forward message and file transfer, which enables the sender to transmit messages or files even when the receiver is not available. In case of temporary unavailability of the receiver, the NSP stores the files and delivers them as soon as the receiver becomes available again.

Next steps – Wrap up

- Set-up your connectivity and send proofs to the BCL.
- Fill in your test registration form and send it to the BCL (to be further explained in the next session)
- BCL will then extract your data and prepare migration files to create your static data on the UTEST environment with the help of ECB and the service desk
- You are invited to send your test registration form by the 15th of November. Your data will be migrated and your profile created on the platform in December and you will access User Testing environment first.
- If you provide your test registration form after the 15th of November, you will be created in January in the next batch. The final deadline to provide your form is the 30th of November.
- Once your party created on the platform, your administrator user can create business users and assign them with role and privileges. Then, the business users can start the testing.
